

# PRIVACY POLICY

## 1. GENERAL

This Privacy Policy Statement ("**Privacy Policy**") explains how Woosh Water Systems Ltd. and/or its affiliates (collectively, "**WOOSH**" or "**We**") collect, use, share, protect and may disclose under certain circumstances, your information and it applies to your use of the website located at the following domain address: <u>www.wooshwater.com</u> (the "**Web Site**"). Your use of the Website is also governed by the terms of use published in the Website (the "**Terms of Use**"). In the event of any conflict between the terms of this Privacy Policy and the terms of the Terms of Use the terms of Terms of Use shall prevail.

We are committed to protecting and respecting your privacy and any information that you may provide us. Please read this Privacy Policy carefully before using the Web Site and review it periodically for the latest information about our privacy practices. By using or browsing the Web Site, you fully agree to the terms of this Privacy Policy.

## 2. THE INFORMATION WE COLLECT

When you use of (including any browse through or access of) the Web Site, we may gather certain information, including the following information:

### 3. HOW WE USE THE INFORMATION

We may use the information we collect and store for the following purposes: (i) to provide, maintain and improve your user experience and Web Site operation; (ii) to send you communications and administrative emails and to provide users with further information and updates with regards to WOOSH's products, technology, etc; (iii) to send you newsletter and/or marketing messages relating to any of WOOSH products (collectively, "Marketing Massage(s)").
